

# The Crucible – Essay Plan

*“How might an audience react to the courtroom scene in Arthur Miller’s play, ‘The Crucible’? What social comments are being made here?”*

In this essay, you need to show **THREE** things:

- That you understand how this play works as a DRAMA
- That you understand the characters and their behaviour
- That your writing is clear, well-planned and easy to follow.

The following are guides to follow when you write your essay. Use the sentence starters, but make sure that you add YOUR OWN ideas and comments.

## **INTRODUCTION:**
